Willson International Group of Companies is a privacy-conscious organization committed to protecting the privacy of our people and those who seek employment with us ("Job Candidates") in accordance with the federal Personal Information Protection and Electronic Documents Act (PIPEDA) and other applicable laws.

# 1. Consent to Collection & Use of Your Personal Information

Willson International Group of Companies uses our Careers website to collect personal information from users of the site. In using the Careers website to seek employment with us, you are agreeing to the collection, use, and disclosure of that personal information as described in this Privacy policy.

# 2. Purpose

The purpose of this policy is to ensure that you understand what information we collect, how we use and disclose it, and how we protect it. To the extent you find any of these collections, uses and/or disclosures objectionable, you should refrain from using the Willson International Careers website to seek employment with us.

#### 3. What is Personal Information?

## 5. Withdrawal of Your Personal Information

All resumes that are discarded will be shredded in confidence.
